4. Committee Reports

Roads and Grounds: Tom Barry

Update on ALD Project

Surveying has been completed including additional information per engineer's request. The engineer is ready to proceed so the \$2,500 retainer needs to be paid. He is scheduled to do the plan in March.

<u>Wetlands</u>

Drainage work at the north end of Ashford Lake Dr. will need a permit. We could request the permit at the same time we request the permit for the ALD project so that the two will be on the same time schedule of meetings. The permit will be good for 5 years so the work can be completed sometime during that time.

Campert Lane

Tom suggested contacting the new Ashford Selectman to follow up on meetings and correspondence with the former Selectmen regarding the town's responsibility in making corrections to the drainage on Campert Lane, which affects Farm Dr. This would also be an opportunity to request that the Selectman use some of the infrastructure money the town will receive for this project. Tom will draft a letter.

Lakeside Trail

The Lakeside trail has been very icy. Extra sand has been applied in that area. Water does not appear to be going to catch basin. This will need to be addressed for a future road project. Harry suggested making boxes available with sand for individuals to use as well.

Environment: Sue Orcutt Blue Green Algae Jason Seacat, 63 Lakeside Dr., recently contacted the Board and is interested in working on the Environmental Committee. He has experience monitoring Cyanobacteria on the Bolton lakes. He suggested an online reporting tool for residents to submit photos to address any emerging issues. He is interested in participating in TLGV monitoring.

The blue green algae seem to be seasonal when temperatures change.

Phragmites

Jordan from JCL Landscaping went out on the ice and cut back and carted away the phragmites. There was no ice at the spillway so the cattails could not be cut down. This will have to be done in the spring since they are obstructing the spillway.

Sue will contact SOLitude Lake Management and ask if our permit for spraying is good for next year.

Recreation: Denise Pillion

Denise suggested a Winter Fest with ice activities and a chili fest. It was decided to be held on Feb 13.

Communication: Ann Milner

A welcome basket was delivered to the new owners of 44 Ashford Lake Dr.
